# BREAST BORDER EXTRACTION AND PECTORAL MUSCLE DETECTION USING WAVELET DECOMPOSITION

Abstract: Digital mammography is used more and more each day in comparison with screen film mammography (SFM). Main advantage of digital mammography for image processing is the use of images with few or no artifacts that can occur on SFM images. Finding breast border contour is therefore easier and gives more precise results. On the other hand, detection of pectoral muscle and breast abnormalities has almost the same results in both cases. The presence of pectoral muscle can affect results of lesion detection algorithms so it is recommended to have it removed from the image. Detection and segmentation of pectoral muscle can also help in image registration for further analysis of breast abnormalities such as bilateral asymmetry. Algorithm presented in this paper uses hybrid method for the pectoral muscle detection. Proposed method uses bit depth reduction and wavelet decomposition for finding pectoral muscle border. Algorithm has been tested on the set of 40 digital mammography images.

*Index Terms:* Digital Mammography, Breast Border, Pectoral Muscle, Segmentation, Wavelet Transform.

# I. INTRODUCTION

In the preprocessing step of any algorithm for automatic mammography image analysis the breast is segmented in order to limit the search for abnormalities without undue influence from background of the mammogram. This step is needed to be done only on digitized SFM images because digital mammography devices perform this step automatically during the image storing process. Breast segmentation consists of breast border contour extraction, pectoral muscle extraction and nipple identification.

On images obtained directly from the digital mammography devices segmentation process is much easier. Previous work from many authors used mammography image databases, especially MIAS [1] and DDSM [2], both comprised of scanned and digitized SFM images. First methods for breast border contour detection were manual [3] and semiautomatic [4]. In the manual methods segmentation is done by a selecting device, like computer mouse, so those methods probably can not be treated as something that is considered to be segmentation today. Among fully automatic methods, gray level thresholding or histogram based methods are dominant [5-8]. Some different approaches like Polynomial modeling [9], Active contours [10, 11], Classifiers and Wavelet decomposition [12] based methods have also been presented. In the paper, where dyadic wavelet decomposition is used [12], importance of decomposition level selection is stressed out. Level selection depends mostly on shape and contours of an object that is to be detected. Another important issue is to choose the object that is going to be detected, the larger object like pectoral muscle or something rather small, like microcalcifications. For larger objects approximation images from dyadic wavelet decomposition are observed and for smaller objects detail images are observed. The higher decomposition level approximation images are chosen for detection of larger objects because they have ability to detect smoother curves. In detection of lesions a fourth level decomposition proved to be the best choice because it preserves enough details and at the same time gives enough blurred image, so "roughness" of the image is suppressed [12].

The pectoral muscle represents a predominant density region in most mediolateral oblique (MLO) views of mammograms and can affect the results of image processing methods [13]. Pectoral muscle appears at approximately the same density as the dense tissues of interest in the image. Therefore, segmentation of pectoral muscle is important in order to limit the search for the breast abnormalities only to the breast "soft tissue" region. For detection and segmentation of pectoral muscle many different approaches have been used. Karssemeijer [14] used the Hough transform and a set of threshold values applied to the accumulator cells in order to detect the pectoral muscle. This method assumes that the edge of the pectoral muscle is approximately a straight line oriented in a certain direction. To ensure that the correct peak is selected in the Hough space, gradient magnitude and orientation, length of projected line and corresponding pectoral area were taken into account. Ferrari et al. [10] presented a technique to detect the pectoral muscle also based upon the Hough transform, which was a modification of the method proposed by Karssemeijer [14]. The difference from the Karssemeijer's method is the use of geometric and anatomical constraints in order to reduce the number of unlikely pectoral lines instead of using threshold value. In their later work, Ferrari et al. [15] presented a technique based upon the Gabor wavelet filter bank. This method overcomes the limitations of a straight-line representation of the pectoral muscle. The method starts by convolving a group of Gabor filters, specially designed for enhancing the pectoral

muscle edge, with the region of interest containing the pectoral muscle. Wavelet filters used to detect pectoral muscle are chosen by knowing the approximate angle of the muscle. Finally, a post-processing stage is used to find the true pectoral muscle edge by selecting only valid lines that are pectoral muscle boundary. In order to segment the pectoral muscle region Aylward et al. [16] used gradient magnitude ridge traversal algorithm at a small scale and at multiple initial points. They resolved the resulting multiple edge definitions via a voting scheme. Raba et al. [8] presented an automated technique for segmenting a digital mammogram into breast region and background with pectoral muscle suppression. They used region growing intensity threshold estimation to locate the pectoral muscle. Mirzaalian et al. [17] presented an approach for pectoral muscle segmentation based on nonlinear diffusion algorithm. Kwok et al. [18] proposed adaptive algorithm that uses knowledge about the position and shape of the pectoral muscle on mediolateral oblique views. The pectoral edge is first estimated by a straight line which is validated for correctness of location and orientation. This estimate is then refined using iterative "cliff detection" to delineate the pectoral margin more accurately. Finally, an enclosed region that represents the pectoral muscle is generated as a segmentation mask.

This paper presents a method for breast skin-air boundary and pectoral muscle detection on digital mammography images. Breast skin-air interface is determined by finding the breast border contour. The border contour is found by a simplified region growing algorithm which can be used because of very good quality images. For pectoral muscle detection a hybrid method is proposed. This method uses reduction in image bit depth to obtain more contrast in the image for easier edge detection. For the process of edge detection, approximation images of the fourth level dyadic wavelet decomposition are being used. After edge detection that uses the Sobel filter a smoothened curve is drawn to segment the pectoral muscle area. In this way, segmented pectoral muscle can easily be removed or its coordinates can be used for image registration process. Test set of images is obtained from digital mammography device. The images are stored in compliance with the Dicom standard in TIFF image format.

The rest of the paper is organized as follows: in Section II breast segmentation technique is described. In Section III algorithm for pectoral muscle detection is explained. In Section IV experimental results are presented. Section V draws the conclusion.

### II. BREAST SEGMENTATION

Process of breast segmentation is the first step in mammography image analysis. It is important to find the skin-air interface, or the breast contour, and define the region of interest (ROI) for further analysis. Breast contour extraction is somewhat easier on higher quality digital mammography images than on digitized screen film mammography images. The reason for that is the absence of objects outside of the breast border and preprocessing that has been done by the mammography device. Digital mammography images are mostly stored in compliance with the Dicom standard. That means that each image contains a header with information about patient, procedure and many technical details concerning imaging device and operating conditions. In Dicom header it is possible to find the information such as view position of the breast and laterality to determine whether the image of the left or the right breast is viewed. That helps in finding proper coordinates of the starting point for finding breast border. Our algorithm for finding breast border contour proposed in this paper is described by the flowchart shown in Fig. 1.



Fig. 1 - Breast border contour algorithm flowchart

In the first step it is important to determine intensity value of the background to be able to find pixels that create the border line. The first objective in segmentation process is to determine the breast orientation, if that information is not possible to obtain from header of the image. Orientation is found by scanning the centre horizontal line of the image from the left and right side until pixel values are higher than the background and determining which of these two distances is shorter. After the orientation is known, the centre of the breast must be found. Centre of the breast is determined by the point of intersection of two perpendicular straight lines, one horizontal and one vertical. These lines are determined in a way that each line is positioned at the coordinate where maximal distance of breast tissue from the image edge is found, as shown in Fig. 2. The found coordinate is named  $(x_0,y_0)$ .

The breast centre has been taken as the starting point for a simple region growing algorithm. The reason for making a simpler algorithm is rather large size of each image (4084×3328) because of which standard region growing algorithm takes too much calculation time. This method works, as expected, very well on digital mammography images. It gives 100% success ratio on our set of 40 digital mammography images, from 20 different patients.

### III. PECTORAL MUSCLE

Pectoral muscle detection is one more challenging task in the breast segmentation process. Reason for detecting pectoral muscle is to remove it or to find some key-points in mammography image so it can be registered afterwards. Registration can help in some auto detect procedures such as finding bilateral asymmetry. The algorithm for pectoral muscle segmentation proposed in this paper consists of few steps as shown in Fig. 3.

Technique for segmenting pectoral muscle presented in this paper uses wavelet decomposition, image blurring and edge detection using the Sobel filter. To detect pectoral muscle it is necessary to know the breast orientation. If the breast orientation is known, it is easy to select the region on which segmentation technique will be applied. Segmentation starts by automatically selecting the desired region. The region of interest containing pectoral muscle is determined by three points. For example, if the image shows MLO view of the right breast, the first point A is top left corner of the image with coordinates (1,1). The second point B is determined by the contour of skin-air interface and the third point C is chosen to be approximately at half of image height while satisfying the condition that  $x_c$  equals to the power of two  $(2^n)$ . This condition is helpful when using wavelet decomposition, because it is important that image height is multiple of  $2^n$  for proper use of wavelet decomposition. By those three points a rectangle is determined as shown in Fig. 4.

After determining the region where pectoral muscle should be detected, the image of the region is supplemented with zeros to get the image with size  $2^n \times 2^n$  as shown in Fig. 5.

Before proceeding with wavelet decomposition, image intensity levels are grouped into 8 bins as shown in Fig. 6. This gives a 3-bit image from a 12-bit start image. Reduction in bit depth helps in better defining pectoral muscle region. That is possible because muscle tissue is mostly uniform density. Since original image is in TIFF image format with 12 allocated bits and information in these images is not contained in all 12 bits, it is necessary to make "windowing" of amplitudes that contain information. This has been done using the algorithm for displaying mammography images correctly as described in [19].

Grouping intensity levels to a few bins is a way of contrast enhancement and results are visible when comparing images shown in Fig. 7.

On a new 3-bit image a dyadic wavelet decomposition of fourth level is being done using algorithm described in [20]. Approximation image of the fourth level wavelet decomposition gives the best results for detecting larger structures, such as pectoral muscle. Fig. 8 shows example of the third level dyadic wavelet decomposition, where HP are high pass components (detail images) and LP are low pass components (approximation images).

The fourth level decomposition gives the best results because it preserves enough "rough" details while at the same time does a very good job in removing fine details like noise and granulation. Use of different wavelet filter banks gives different results. In this paper, a reverse biorthogonal spline wavelet filter has been used, Fig. 9.

The approximation image is then interpolated using wavelet based interpolation technique [21] to get the image that is the same size and brightness as the original decomposed image. Fig. 10 shows the original and the decomposed image after interpolation.

Since the interpolated image is also granulated, a blurring filter is used to get smoother edges before thresholding and edge detection. For blurring an averaging square filter of size  $40 \times 40$  pixels has been chosen, where each cell ( $\alpha_{i,i}$ ) is defined by (1).

$$\left(\alpha_{i,j}\right) = \frac{1}{n \cdot n},\qquad(1)$$

where *n* is matrix height and width.

Thresholding of the blurred image gives better results because gray amplitudes are more evenly spread, giving a straighter line, more similar to the muscle boundary. After thresholding, gradient filtering (2) using the Sobel filter with matrix size  $3\times3$  shown in Fig. 11 is used to detect muscle edges:

$$\nabla f = grad(f) \equiv \begin{bmatrix} g_x \\ g_y \end{bmatrix} = \begin{bmatrix} \frac{\partial f}{\partial x} \\ \frac{\partial f}{\partial y} \end{bmatrix}, \quad (2)$$

where *f* is image gradient defined by two orthogonal components,  $g_x$  and  $g_y$ .

Another smoothing is required to get cleaner boundary after the edge detection. Edges that were detected by the Sobel filter inside the pectoral muscle region are removed by approximating muscle boundary with a straight line (3) that connects upper right corner and lower left corner of muscle region in the case of the right breast image:

$$y = y_1 + \frac{y_2 - y_1}{x_2 - x_1} (x - x_1), \qquad (3)$$

where  $x_i$  and  $y_i$  are coordinates of points that create a straight line.

This approximation works well because the pectoral muscle border is either straight line or slightly concave curve. The muscle contour is then easily found and pixel values can be used for the muscle removal in the original image or to calculate parameters for the image registration.

## IV. EXPERIMENTAL RESULTS

Algorithm proposed in this paper is tested on a set of 40 MLO digital mammography images, from 20 different patients (2 images from each patient). Each image has resolution of  $4084 \times 3328$  pixels with 12 bits per pixel. The image format is uncompressed TIFF. All images are stored in compliance with Dicom standard. Mammography imaging device is MAMMOMAT Novation<sup>DR</sup>, manufactured by Siemens, that has  $\alpha$ -Selenium direct conversion detector and uses Wolfram/Rhodium anode/filter combination [22].

Skin-air interface or breast border contour detection gave excellent results with success ratio of 100%. Reason for this success lies in high quality of our experimental image set (digital mammography images commonly used in today's medical imaging). Every image has well defined background, what makes thresholding easier and simple region growing in four directions from defined breast centre as a seed point gives excellent results.

Fig. 12 shows example of breast border image superposed to original image. The border contour is defined as the first pixel with background intensity outside of the breast region.

Fig. 13 shows a detail of detected border around nipple region.

Pectoral muscle detection is a more complex problem than breast border contour detection. Technique presented in this paper uses wavelet decomposition to obtain the image with less fine details and smoother muscle line for edge detection. In Fig. 14 an example of the approximation image after the fourth level wavelet decomposition is shown.

After wavelet decomposition the edges are found using the Sobel filter. The resulting image is then blurred using averaging filter to get smoother line and the edges inside muscle area are removed. Result of this process is shown in Fig. 15.

Results of segmentation process are shown in Fig. 16 where pectoral muscle segmentation line is superposed to the segment of the image that contains detected pectoral muscle.

Results of pectoral muscle segmentation are divided in three groups and shown in Table 1. Total percentage for "Good", "Acceptable" and "Unacceptable" results are shown at the end of each column.

# V. CONCLUSION

In this paper a method for the detection of the breast border contour and the pectoral muscle segmentation is presented.

The proposed method for detecting the breast border contour works well on our test set containing 40 digital mammography images. This method gave 100% success in detecting the correct skin-air interface. The main reason for that is very good quality of tested images because of the preprocessing stage done by the mammography device. Screen film mammography image breast border detection would not be near as successful as the same detection on digital mammography images because scanned SFM images are not preprocessed and film often contains artifacts that can cause problems in automatic detection. Advantage of this method is low algorithm complexity and therefore short processing time. Border contour can easily be used for the image registration process and segmented breast region for a histogram based image optimization. Our further research will focus on detection of skin tissue outside of the breast region in order to make even better segmentation.

Pectoral muscle detection proved to be a more challenging task because it is not very well differenced from the surrounding breast tissue. Each mammography image has different intensity variation of the pectoral muscle and the surrounding tissue and therefore contrast based methods have problems in segmenting it correctly. The method proposed in this paper uses contrast enhancement by converting groups of intensities from original image to 8 discrete values, creating a 3-bit image. This helps in making edges easier to spot and to detect using gradient filtering. Wavelet decomposition is used to make an image that contains fewer details than the original one that results in fewer detected edges. This approach works well because pectoral muscle is rather large object for detection. Further development concerns smoothing of the pectoral muscle segmentation line as well as finding the method that gives better results in automatic thresholding before edge detection filtering.
